Making a gift of securities

A step-by-step guide

Step 1:

Please complete all sections of the securities transfer form attached.

For privacy reasons, your broker cannot disclose your name to us, so please complete the Donor Information section, including your daytime phone number with area code. Your advisor/broker will provide the CUSIP # which acts like a transaction number in case the transfer needs to be tracked.

Step 2:

Send a copy of the completed transfer form for processing to Paula McKinley at the Heart and Stroke Foundation of New Brunswick for processing. This step is important because securities are transferred into our account anonymously, without your name listed. Notifying us will ensure you receive your official receipt for income tax purposes.

Step 3:

Fax or send the completed transfer form to your broker or investment advisor. Your broker or investment advisor is responsible for initiating the transfer.

Additional information:

Securities, shares and stocks are considered legally transferred only when our custodial agent RBC Dominion Securities confirms delivery. Your receipt is valued based on the closing price on the day when the shares are legally transferred to Heart & Stroke's account. Heart & Stroke's policy is to sell the shares as soon as possible after they have been received.
